# 9.1 Application for an amendment to the Zoning By-law, Re: McGill Street R-29-19

Moved by Yves Paquette Seconded by Robert Lefebvre

**Whereas** the Town has adopted a new Zoning By-law N° 20-2018 on April 30, 2018 and is subject to the *Smart Growth for our Communities Act, 2015* resulting in no amendments being permitted until April 30, 2020, and;

**Whereas** the *Smart Growth for our Communities Act, 2015* is intended to give municipalities greater stability and control over their planning documents. This Act stipulates that no person or public body may submit an application for a Bylaw amendment before the second anniversary of the day on which the Council passed the said By-law, and;

**Whereas** this section does not apply in respect of an application, if the Council has declared by resolution, that it is permitted. Such a resolution may be adopted in respect to a specific application, a class of applications or in respect of such applications in general.

**Be it resolved** to agree that the Planning Department undertakes the Zoning Bylaw amendment process for the property located at 370 McGill Street, as recommended in document 2019-REC-08.

9.3 Proposal for a forest cover by-law R-30-19

Moved by Yves Paquette Seconded by Raymond Campbell

**Whereas** the Province has amended the *Municipal Act, 2001* and has proclaimed that each municipality must adopt and implement policies regarding the manner in which it will protect and strengthen the forest and natural vegetation in the municipality. The by-law must be in effect by March 1, 2019, and;

**Whereas** the Town does not have a specific policy on the protection of forest cover on its territory, and;

**Whereas** the Town will be in the process of a five-year review of its Official Plan and a policy in accordance with the Province requirements will be included in the said plan.

**Be it resolved** to adopt the proposed by-law that reflects the policies of the Official Plan of the United Counties of Prescott & Russell, as recommended in document 2019-REC-10.
