Hourly Rate for Tri-axle Truck: 84.00 \$/hour (plus HST)
 Specification for Tri-axle Truck: Two (2) foot boards on box on the driver's side only. This is subject to inspection and approval by the Public Works Superintendent.

Hourly Rate for Tandem Truck: 78.00 \$/hour (plus HST)
 Specification for Tandem Truck: Two (2) foot boards on box on the driver's side only. This is subject to inspection and approval by the Public Works Superintendent.

POLICY
HIRING OF LOCAL CONTRACTORS FOR SUPPLYING OF
TRI-AXLE AND TANDEM TRUCKS FOR SNOW REMOVAL

1. During snow removal, the Town of Hawkesbury will use their own trucks as much as possible;
2. Should the Superintendent of Public Works require additional trucks, the following procedure and policy shall apply:
 - a) The Superintendent shall include any local contractor who has expressed an interest in providing a vehicle for snow removal activities on a calling list for provision of such services and shall have the contractor sign this "Snow Hauling Agreement" which sets forth the hourly rate, truck specifications and acknowledgment of this policy. Vehicles must comply with safety regulations instituted by the Superintendent;
 - b) The Superintendent shall maintain a calling list of those contractors wishing to participate and shall provide, when convenient, an 8-hour notice period for the evening (current) snow removal activity;
 - c) The Superintendent shall call contractors on a rotating and descending order basis, and shall offer the possibility of providing one (1) tri-axle or one (1) tandem for a scheduled snow removal activity based upon the number of trucks, the Superintendent, requires for that specific scheduled activity;
 - d) When the number of trucks required has been obtained, the next and subsequent contractor(s) on the list, shall be contacted for the next snow removal activity and this process shall continue for each subsequent snow removal activity;
 - e) Two (2) subsequent refusals without legitimate reasons by a contractor shall result in the contractor being removed from the calling list for the current winter;
 - f) All contractors' operators must operate their trucks in a safe and appropriate manner at all times and must comply with the Town's Occupational Health and Safety Policy;
 - g) The Superintendent, at his sole discretion, shall have the authority to remove or not accept the renting of a vehicle from a local contractor in the event that the operator for the contractor is not performing the required duties requested by the Superintendent of Public Works.
 - h) If a contractor agrees to work for a shift, they must show up on time. They are not permitted to leave until advised by the Superintendent or Lead Hand in charge of the snow removal event.
 - i) **Upon submitting their signed agreement, contractors shall provide proof of comprehensive general liability insurance covering bodily injury and property damage of at least \$ 5,000,000.00 naming the Town of Hawkesbury as an additional insured, and proof of a member in good standing with WSIB (clearance certificate). These must be maintained for the duration of the 2020-2021 winter.**
