

## Notice of the Passing of a Development Charges By-law

(D02-18)

**TAKE NOTICE** that the Council of the Corporation of the Town of Hawkesbury passed a municipal-wide development charges By-law N° 16-2020 on the 8<sup>th</sup> day of June 2020, under section 2 (1) of the *Development Charges Act, 1997, S.O., 1997 c. 27*, as amended;

**AND TAKE NOTICE** that any person or organization may appeal to the Local Planning Appeal Tribunal under section 14 of the Act, in respect of the development charges by-law, by filing with the Clerk of the Corporation of the Town of Hawkesbury on or before **the 18**<sup>th</sup> **day of July 2020**, a notice of appeal setting out the objection to the by-law and the reasons supporting the objection.

The schedule of development charges imposed by the by-law, which came into effect on *June 9, 2020*, is as follows:
