2022 Municipal Elections – Financial Statements

Certified Candidates for the 2022 Municipal and School Board Election are required to file their initial financial statement and auditor's reports on or before 2 p.m., March 31, 2023 (*Municipal Elections Act*, 1996, section 88.30). Completed Financial Statements can be consulted upon request made to the Clerk's office.

As per subsections 88.23 (4) and (5), the Clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with section 88.25. 2016, c. 15, s. 60. This report mentioned shall be made available on a website or in another electronic format.
