## Bulky waste collections - 2024

Collections will take place the same day as the regular garbage and recycling collection for each route (see map) but will only take place during the special collection weeks indicated on the waste collection calendar (and listed below). May 27 to 30 | June 24 to 27 | July 22 to 25 | August 26 to 29 | September 23 to 26 | October 21 to 24

## Bulky waste – accepted items

Each collection is restricted to 2 accepted items per household according to this list of accepted bulky waste items with restrictions. If you have questions about whether or not an item is accepted or if you believe there is an item that should be added to the list, email tp-pw@hawkesbury.ca or call 613-631-0106.

NB: In all cases, if an item is reusable, the Town encourages that items be dropped off at an appropriate second-hand store or reuse center. If an item is small enough to fit in the regular garbage or recycling container, **AND** consists of an accepted item in either of those collections, please dispose of it during those respective weekly collections.

Waste type	Restrictions
Pool filters and water softener tanks	Water and Sand must be emptied
Mattresses & boxsprings	
Electronics (including television, computer, monitor, VCR, DVD player, and printer)	Contact Recycle-Action to drop off accepted items at recycling center year-round or set out curbside during the bulky waste collections.
Household appliances (including refrigerator, dishwasher, washer, dryer, microwave, oven, air conditioner, dehumidifier, humidifier, freezer, and furnace)	*Contact Recycle-Action to drop off accepted items at recycling center year-round or set out curbside during the bulky waste collections.  *Doors must be removed when set out curbside during Bulky waste collections.  *The freon must be emptied by a certified technician and the item tagged accordingly.
Furniture (including tables, chairs, sofas, change tables, sectionals, crib, desk, air hockey table, dresser, entertainment – TV stand	Sectionals (1 piece counts as 1 item)
BBQ (NOT propane tanks)	
Garden tools (including unusable, broken shovels, rakes, and leaf blower)	
Lawn mower	
Exercise equipment (including bicycle, skis, stationary bicycle, rower, treadmill, and golf push cart)	
Pool liners, pool covers and small kiddy pools	
Household furnishings (including area rug, exhaust hood, toilet, laundry basket, laundry sink, kitchen sink or bathroom sink, filing cabinet, floor	*Rugs are accepted but not wall-to-wall carpeting (considered CRD¹ waste)  *Laundry, kitchen or bathroom sinks must be independent,
lamp, ironing board, ladder, suitcase, and piano)	without any counter. Counters are considered CRD <sup>1</sup> waste and are not accepted in the bulky waste collections.

<u>CRD</u> - Waste created during the construction, renovation and demolition (<u>CRD</u>) of buildings, as well as yard waste (such as branches) are <u>NOT ACCEPTED</u> during the bulky waste collections.
