Hawkesbury Crime Unit – Unité des enquêtes criminelles

Investigation of interest: Nation Municipality:

On the 16th of September, Hawkesbury OPP members responded to a threatening call. Officers received information that the suspect would have threatened to kill two individuals. While making the threats the suspect sent the victims pictures of him holding numerous firearms. Victims were from different regions. As a result, the investigation led to a well-coordinated effort by frontline members and Crime unit members from both Hawkesbury and Russell detachments along with members of the ERT and TRU teams, ROPE unit and our Forensic Identification unit which led to the suspect being located and arrested. Members of the Hawkesbury Crime Unit executed 3 search warrants at 2 residences and 1 vehicle which led to the seizure of firearms. The suspect is currently being detained at the Ottawa detention center.

Enquête d'intérêt : Municipalité de la Nation :

Le 16 septembre, les membres de la Police provinciale de l'Opp de Hawkesbury ont répondu à un appel menaçant. Les agents ont été avisés que le suspect aurait menacé de tuer deux personnes. Tout en proféré des menaces, le suspect a envoyé aux victimes des photos de lui tenant de nombreuses armes à feu. Les victimes venaient de différentes régions. Par conséquent, l'enquête a mené à un effort bien coordonné de la part des membres de première ligne et des membres de l'unité criminelle des détachements de Hawkesbury et de Russell, ainsi que des membres des équipes d'EIU et de TRU, de l'unité ROPE et de notre unité d'identité judiciaire, ce qui a permis de trouver et d'arrêter le suspect. Des membres de l'Unité criminelle de Hawkesbury ont exécuté 3 mandats de perquisition dans 2 résidences et 1 véhicule, ce qui a mené à la saisie d'armes à feu. Le suspect est actuellement détenu au centre de détention d'Ottawa.














